All participants, especially those who may be pregnant; be disabled in any way; or have recently suffered an illness, injury or impairment; are encouraged to consult a physician before undertaking a physical activity.

I recognize and acknowledge that there are certain risks of danger, accidents, and physical injury when engaged in throwing, catching, hitting, sliding, fielding, running, jumping, games and play, and I voluntarily agree to fully assume such risks, regardless of severity, including death, damages, or loss which I or my minor child may sustain as a result of my child's participation in any and all activities connected with or associated with programs provided by BAAF.
